Prior Learning

The course builds on prior learning by... supporting learners' progression from any study at Level 2, particularly GCSEs in Sociology, Law, Psychology, Citizenship, History and Humanities. It allows development of skills acquired at GCSE such as the ability to apply, analyse and evaluate.

Curriculum Intent – What are the curriculum aims?

- Unit 1 enables learners to demonstrate understanding of different types of crime, influences of perceptions of crime and why some crimes are unreported
- Unit 2 allows learners to gain an understanding of why people commit crime, drawing on what they have learned in Unit 1
- The course allows learners to consider how the use and application of their learning impacts upon themselves, other individuals, employers, society and the environment
- The applied purpose allows learners to develop:
 - Skills required for independent learning and development
 - The ability to solve problems
 - The skills of project based research, development and presentation
 - The ability to apply learning in vocational contexts
 - To gain the required understanding and skills to be able to consider employment within some aspects of the criminal justice system

Curriculum Impact – How will my child be assessed and receive feedback?

Unit 1: This unit is internally assessed and externally moderated. In two sittings, students will complete an 8-hour assessment under controlled conditions.



Unit 2: 90-minute external examination.

In-class: Exam style questions, extended written assessments and a range of informal assessment opportunities. Students will receive a combination of verbal and written feedback from teaching staff, dependent on the type of work produced. Pupils will be expected to participate actively in whole-class discussions.
