Prior Learning

Law is new to students in year 12, so no prior knowledge of law is required. However, good English and writing skills are necessary as Law is an essay based subject. Students will build on English writing and interpretation skills acquired from GCSE.

Curriculum Intent - What are the curriculum aims?

The course aims to give students a thorough knowledge of the Legal System of England and Wales. *Specifically:*

- A knowledge of the different courts and court systems and the alternatives to using the civil courts.
- The people who work in the legal system.
- How laws are made and interpreted in England and Wales, including the effect of European Law on domestic law.
- An introduction to criminal law and specific knowledge of the non-fatal offences against the person.
- An introduction to the law of tort with specific knowledge of negligence and occupiers' liability.

H418 in year 12 is assessed by two internal exams, Paper 1 and Paper 2. These are marked and moderated internally using guidance in the mark schemes published by the OCR exam board.

In-class: formal tests and homework tasks. Assessment will be by a mixture of teacher marking, peer assessment and self- assessment. There will be a combination of verbal and written feedback from teaching staff, dependent on the work produced.
